10. The proposed reduction in non-bargaining unit staff to address the budget shortfall. Please include the agency, position, and the annual total cost of the position.
11. A complete list of all sub-contractors that the State of Ohio currently uses and the cost associated with each.
12. Copies of any and all documentation concerning, addressing or relative to the current budget shortfall and plans to address said shortfall (e.g. savings measures or the like).
13. Copies of all applications to the federal government for compensation and or assistance that are in any way related to the current state of emergency or COVID-19 pandemic.
14. A complete list of all monies received from the federal government in relation to the current state of emergency or the COVID-19 pandemic.
15. A complete list of the expenditure of any monies received under items 13 and 14 above.
